NEW DEAL FOR TEACHERS IN WALES

NASUWT wants the new Westminster Government to commit to a new deal and new policies which will help to improve education for every child and young person in Wales and across the UK.

Children's lives and futures are being damaged, principally by a lack of investment in our schools, colleges and wider support services for children and families. More teachers and headteachers are leaving the profession prematurely, whilst targets to train the next generation of teachers are being missed, holding back a generation and damaging our country's prospects for the future.

Our children and young people deserve better.

We believe that investing in a brighter future for our children starts with investing in our teachers.

FULLY FUNDING EDUCATION

We want all schools and colleges to have the resources they need to secure the best educational opportunities for children and young people. However, as a result of the Westminster Government's policy of austerity, schools in Wales have seen teacher numbers decline significantly during a period when pupil numbers have remained high by historical standards. Between 2011 and 2023, the total number of EWC-registered teachers fell by 7.5% from 38,770 in 2011 to 35,837 in 2023. This trend has had an adverse impact on pupil/teacher ratios, particularly in primary schools, in which between 2010 and 2023, the pupil/teacher ratio increased from 20.1 to 20.9. Over the same period, the average junior class size increased from 24.7 to 25.7 pupils.

We want the next Westminster Government to deliver a New Deal that will:

- secure improved funding for schools, colleges and other public services;
- invest in the infrastructure of wider support services for children and families.

BARGEN NEWYDD I ATHRAWON YNG NGHYMRU

ARIANNU ADDYSG YN LLAWN

Rydym am i bob ysgol a choleg gael yr adnoddau sydd eu hangen arnynt i sichrâu'r cyfleoedd addysgiadol gorau i blant a phobl ifanc. Fodd bynnag, o ganlyniad i lymder Llywodraeth San Steffan, mae ysgolion yng Nghymru wedi gweld niferoedd athrawon yn gostwng yn sylweddol yn ystod cyfnod pan fo niferoedd disgylion wedi aros yn uchel yn hanesyddol. Rhwng 2011 a 2023, gostyngodd cyfanswm yr athrawon a gofrestrwyd gyda CGA 7.5% o 38,770 yn 2011 i 35,837 yn 2023. Mae'r duedd hon wedi cael effaith andwyol ar gymarebau disgylion/athro, yn enwedig mewn ysgolion cynradd, lle rhwng 2010 a 2023, cynyddodd y gymhareb disgylion/athro o 20.1 i 20.9. Dros yr un cyfnod, cynyddodd maint cyfartalog dosbarthiadau iau o 24.7 i 25.7 o ddisgylion.

Rydym am i Lywodraeth nesaf San Steffan gyflwyno Bargen Newydd a fydd yn:

BARGEN NEWYDD I ATHRAWON YNG NGHYMRU

PROVIDING SECURITY IN EMPLOYMENT/WORKING IN PARTNERSHIP

Raising the status of teaching means ensuring that all teachers are respected and treated as highly skilled professionals. Teachers want to see a government that is committed to securing good industrial relations through dialogue and consensus-building, whatever the sector of work. And all teachers should be able to exercise their rights freely and, where necessary, take appropriate action to defend their terms and conditions of service.

We want the next Westminster Government to deliver a New Deal that will:

- ban the use of zero hours contracts;
- prohibit the use of fire and rehire;
- require all school employers in the independent sector to recognise trade unions for the purpose of collective bargaining;
- repeal anti-trade union legislation;
- devolve employment law to go above and beyond the UK-wide statutory employment framework to the benefit of all working people.

TACKLING DISCRIMINATION

Every teacher, irrespective of background, should feel confident that they can progress and succeed in their chosen career, and be supported to work free from discrimination and harassment.

We want the next Westminster Government to deliver a New Deal that will:

- require school and college employers to publish clear and consistent details of their individual gender, ethnicity and disability pay gaps;
- improve provisions around maternity and paternity leave/pay, including miscarriage leave;
- require social media companies to tackle online threats to and abuse of teachers.

Mae codi statws addysgu yn golygu sicrhau bod pob athro yn cael ei barchu a'i drin fel gweithwyr proffesiynol medrus iawn. Mae athrawon eisiau gweld llywodraeth sydd wedi ymrwymo i sicrhau cysylltiadau diwydiannol da trwy ddeialog a meithrin consensws, beth bynnag fo'r sector gwaith. Dylai pob athro allu arfer ei hawliau yn rhydd a, lle bo angen, cymryd camau priodol i amddiffyn eu telerau ac amodau gwaith.

- gwella darpariaethau yng hylch absenoldeb/tâl mamolaeth a thadolaeth, gan gynnwys absenoldeb camesgor;
